The Health Story Project and Health Level Seven International to Host Webinar on How to Exchange Basic Records and Meet Early Meaningful Use Requirements (Part II)

Learn how HL7 CDA and CCD templates support meaningful use for exchanging basic records even prior to EMR system adoption.

International, the global authority for interoperability and standards in healthcare information technology, and the Health Story Project, a collaborative of healthcare vendors, providers and associations, will present a complimentary webinar on Wednesday, December 1 from 10:00 – 11:00 am ET to discuss how healthcare providers can exchange basic records and meet early meaningful use requirements. The webinar is also co-sponsored by the Association for Healthcare Documentation Integrity (AHDI) and the Clinical Documentation Industry Association (CDIA).

Physicians in the U.S. create more than a billion clinical notes each year, comprising around 60% of clinical information. These clinical notes are used as the primary source of information for reimbursement and proof of service. With standards, the output can easily integrate with Electronic Medical Record (EMR) systems and Health Information Exchanges and provide a smooth path to interoperability. The Health Story Project is an industry collaboration working to accelerate the development and adoption of standards for electronic clinical documents using HL7 Clinical Document Architecture (CDA) and Continuity of Care Document (CCD) templates. The Health Story Project and Health Level Seven have an associate charter agreement and have jointly produced eight implementation guides thus far. Further standards for electronic clinical documents are currently under development within HL7.

Many vendors can produce electronic documents based on the HL7 CDA. "We need to raise awareness of this option," said Bob Dolin, MD, chair of Health Level Seven International and principal of Semantically Yours, LLC. "Many EMR system vendors do not know that companies in the transcription and clinical documentation industry can produce and offer electronic documents in the CDA format. Additionally, providers are not aware that they can ask for this approach to discrete data capture, which is minimally disruptive to clinician workflow."
