Introduction

The Implementation Guide (IG) for Patient Friendly Language for Consumer User Interfaces, May 2015 is the result of collaborative efforts between Veterans Health Administration (VHA) and Substance Abuse and Mental Health Services Administration (SAMHSA).

This IG is sponsored by Veterans Affairs (VA) and is the result of a focused effort to provide a patient friendly language/plain language healthcare vocabulary. This vocabulary is targeted specifically toward healthcare consumer user interfaces which create outputs for consumer consumption such as consent directives, reports of disclosures, and notices of privacy practices.

Patients are often uncomfortable with the provided technical/legal security and privacy jargon used in healthcare consumer user interface outputs for consumer consumption. This technical/legal jargon makes it difficult for patients to fully participate in decisions regarding their healthcare (for instance, giving consent for access by providers to share medical information with other providers as needed for coordinating patient care). By using plain language¹ vocabulary that is mapped to technical/legal jargon in healthcare consumer user interface outputs for consumer consumption, we increase the likelihood that patients understand the choices they make while ensuring that their choices are correctly translated across the system.

The existing HL7 Healthcare Privacy and Security Classification System (HCS)² standard contains privacy and security topics. While these topics are expressed using technical jargon in the HCS, healthcare consumer user interface outputs for consumer consumption need to express them in plain language. This IG provides a mapping of technical/legal security and privacy jargon to suggested plain language vocabulary. This mapping covers HCS topics such as purpose of use, sensitive condition restrictions, opt-in/opt-out, and other privacy- and security-related topics found in healthcare consumer user interface outputs for consumer consumption.

Although not mandatory, it is expected that implementers will use the vocabulary provided in the mapping in order to conform to plain language guidelines. We provide conformance guidance for healthcare consumer user interface outputs for consumer consumption. Conformance guidance for specific types of healthcare consumer user interface outputs for consumer consumption can be added as demand dictates.

Additionally, this IG seeks to support a Fast Healthcare Interoperability Resources (FHIR) consent directive questionnaire. This would increase portability and interoperability of consent directives across healthcare providers.

Purpose

This IG presents patient friendly/plain language that may be useful for incorporation in healthcare consumer user interface outputs for consumer consumption.

Audience

This IG is designed for:

- Clinical and Public Health Laboratories
- Healthcare Institutions (hospitals, long term care, home care, mental health)
- Individual Healthcare Providers
- Electronic Health Record (EHR) and Personal Health Record (PHR) Vendors
- Clinical Decision Support Systems
- Standards Development Organizations (SDOs)
- Public Health Agencies
- HIEs
- Food and Drug Administration (FDA)
- Ambulatory providers (physician clinics, dental clinics, mental health/behavioral health, etc.)

Scope

To present a patient friendly/plain language that may be incorporated in healthcare consumer user interface outputs for consumer consumption. Such patient friendly healthcare consumer user interface outputs for consumer consumption would provide the capability to:

- 1. Make it possible for patients to better understand choices offered to them by a healthcare user interface output for consumer consumption;
- 2. Allow for direct interpretation of patient friendly language choices into the technical jargon found in HL7 specifications;
- Assist with the reporting of disclosures by ensuring that any report of disclosures is
 presented in a patient friendly manner. Specifically, this will ensure that any report of
 disclosures containing technical security terms and provenance information is translated
 into patient friendly language; and
- 4. Make it possible for patients to better understand informed consents when participating in clinical trials.

Creating a FHIR consent directive resource also falls within this project's scope. This would increase portability and interoperability of consumer user interface outputs for consumer consumption such as consent directives across healthcare providers. Note that this IG is intended to be policy agnostic.

Conformance

An implementation is said to be conformant to this HL7 IG when it follows the specified guidelines for writing in patient friendly language.

These guidelines should be followed by implementers when incorporating patient friendly/plain language in healthcare consumer user interface outputs for consumer consumption. Such language uses vocabulary that is simple, plain, and familiar to patients with concise verbiage.

This IG includes a mapping of technical/legal jargon commonly found in healthcare consumer user interface outputs for consumer consumption to vocabulary that is patient friendly. In order to be conformant to this HL7 IG, implementers should also use the suggested plain language vocabulary provided in the mapped table in place of the technical/legal jargon when developing healthcare consumer user interfaces that create outputs for consumer consumption.

In different policy domains, the selection of patient friendly vocabulary might be different. However, when implementers develop HL7-compliant healthcare consumer user interfaces that create outputs for consumer consumption, they should use the suggested plain language vocabulary provided by this IG unless the language is in conflict with language required by legal and regulatory requirements.

Guidelines for how to incorporate patient friendly/plain language in HL7-compliant healthcare user interface outputs for consumer consumption are specified in the next section. Immediately below is a list of the references that directly informed the guidelines. Appendix A contains a full list of references that support this IG.

Gives guidelines to assist in creating easy-to-read health materials for audiences who have difficulty reading or understanding information.

Guidelines

The healthcare consumer user interface should create outputs for consumer consumption which use language that a patient can easily and quickly understand. Such language is comprehensible to patients at the 6th-8th grade reading comprehension level.

 These outputs should use common, everyday words and phrases that can be found in language thesauruses and word lists to replace or define technical/legal jargon.

The healthcare consumer user interface should create outputs for consumer consumption which use active voice.

- Readers more easily follow text when it's clear who is taking the action. The subject of the sentence takes the action expressed by the verb.
- An example of writing in active voice is: "We ask questions about your sharing preferences to protect your privacy."

The healthcare consumer user interface should create outputs for consumer consumption which are written in a conversational style.

Write in the first person or second person, using pronouns such as "I," "we," and "you."
 This encourages the use of active voice and will be clearer and more engaging to the patient.

The healthcare consumer user interface should create outputs for consumer consumption which are written in concise sentences.

Vary the length of your sentences, which should average 15 words or less. This will
ensure that your healthcare consumer user interface output flows smoothly.

The healthcare consumer user interface should create outputs for consumer consumption which use reader friendly formatting.

- Ensure the headings stand out by using large font, bold, or other emphasis (the font size should be two points greater than the text that follows). As measured vertically from the baseline of the character, the font size should be 5/8 inch (16 mm) minimum and 2 inches (51 mm) maximum based on the height of the uppercase letter "I."³
- Use headings that provide a meaningful description of the content of different sections.
- Break up chunks of information. Take long lists embedded in sentences and convert them into bulleted lists with one point per line. Number the lists if order is important.

The healthcare consumer user interface should create outputs for consumer consumption which are organized in a way that places the most important information first.

- Put the most important information first.
- If your patients need to follow a process, make sure that the steps are in chronological order.
- Clearly explain what your patients need to do and when they need to do it. For instance, include specific due dates if there is a deadline.

The healthcare consumer user interface should create outputs for consumer consumption which use language that is sensitive to the patients' special needs and ability of interpretation.

 Ensure your healthcare consumer user interface output meets the special needs of your patients. In the U.S., this means following all the requirements for Section 508 compliance⁴ to meet the needs of patients with disabilities such as visually impaired individuals.

Vocabulary Mapping

The table below maps technical/legal jargon commonly found in healthcare consumer user interface outputs for consumer consumption to vocabulary that is patient friendly (see the suggested plain language provided in the second column). Most of the plain language suggestions were determined from careful consideration of the plain language alternatives provided by the HIPAA Plain Language Thesaurus (fifth column), CDC Plain Language Thesaurus (sixth column), and GroupHealth Plain Language Toolkit (seventh column). HL7 subject matter experts (SMEs) made additional plain language suggestions, and these are found in the third column. Definitions of technical privacy and security jargon found in the HL7 HCS standard are provided in the fourth column. The table also includes suggested plain language for the HCS jargon (in the second column).

Appendix B contains examples of how to use the patient friendly vocabulary and guidelines specified in this IG to translate language commonly found in consent directives to patient friendly language. This appendix objectively measures the "patient friendliness" of each example by using the Flesch Reading Ease test and Flesch-Kincaid Grade Level test. Note: these tests are available in Microsoft Word through the "Show readability statistics" feature.

APPENDIX B - Consent Directive use case

Each of the tables on the next three pages shows an example of how to use the patient friendly vocabulary and guidelines specified in this IG to translate language commonly found in consent directives to patient friendly language. This use case pulls language from the Florida AHCA's *Universal Patient Authorization Form for Limited Disclosure of Health Information* (reference 12 in Appendix A).

This use case objectively measures the "patient friendliness" of each example by using the Flesch Reading Ease test and Flesch-Kincaid Grade Level test. Note: these tests are available in Microsoft Word through the "Show readability statistics" feature.

<u>This Microsoft Office site</u> explains that both readability tests base their score on the average number of syllables per word and words per sentence. The site provides a formula for how each test computes its score:

"Flesch Reading Ease test

This test rates text on a 100-point scale. The higher the score, the easier it is to understand the document. For most standard files, you want the score to be between 60 and 70.

The formula for the Flesch Reading Ease score is:

 $206.835 - (1.015 \times ASL) - (84.6 \times ASW)$

where:

ASL = average sentence length (the number of words divided by the number of sentences)

ASW = average number of syllables per word (the number of syllables divided by the number of words)

Flesch-Kincaid Grade Level test

This test rates text on a U.S. school grade level. For example, a score of 8.0 means that an eighth grader can understand the document. For most documents, aim for a score of approximately 7.0 to 8.0.

The formula for the Flesch-Kincaid Grade Level score is:

 $(.39 \times ASL) + (11.8 \times ASW) - 15.59$ "
