Infrastructure Support 3) Project updates	The last ballot round CIMI published materials in a zip file which is not the preferred modality. CIMI would like to publish their materials as HTML based website in an automated fashion. They have discussed this with publishing already and are bringing this request to EST. They also are here to add their tools to EST tooling inventory and have added tools to the HL7 GIT hub. HPSC also needs to know what tools are available to support inventory tools and establish knowledge of tools are available (Suggestion for HPSC to maybe use HL7 inventory tool - topic take offline.)		
4) Website updates	LorraineC - What are the steps for CIMI to get HL7 to publish/make web available their materials? Currently hosted at OpenCim i.org.		
5) Parking Lot	They take the base model and Open Archetype and apply tooling to generate a website. It also makes use of OpenEHR tools, but these tools exist in the OpenEHR space, tools specific to CIMI publication process would exist on the HL7 GIT space.		
6) other issues	CIMI is working on tooling to support logical models and is adding this to the HAPI FHIR project.		
	They intend to develop a publication framework, like FHIR, but using available open source tools for example using DocBook.

	3) work on maturation GIT hub publication process		
	DJ - The FhIR standard is built locally by Grahame then it is ftp'd to the HL7 website.		
	LC - The CIMI materials would be generated from GITHUB directories and loaded to the HL7 website		
	We looked at the CIMI materials on the HL7 GitHub site.		
	DJ indicates that getting this process should be feasible maybe for the Jan. 2018 ballot, or perhaps, later in 2018.		
	CN - CIMI is also planning to use JIRA and Confluence for future notes and as an issue control (Jira). It may require workflows in JIRA that maybe peculiar to CIMI with Detailed Clinical Models. CIMI would like a continuously available comment systemwould JIRA support this.		
	3) Question - What is the status of Chat.HL7.org? Close to being available but not quite yet ready. (DJ)		
	chat.hl7.org - is meant to be a discussion platform for the rest of HL7.
