Hey Jean,

I got a chance to connect with Ted Klein on Friday regarding our Harmonization proposal, and based on his discussions and recommendations from Patrick Cannady on our call on Thursday, here's what I think we need to do:

- 1) Adjust our proposal to the use the SNOMED ConceptIDs (that are also part of SNODENT) as the identifiers in our value sets. Per Patrick, the shortened identifiers you provided are more "internal" identifiers that systems are less likely to use does that sound right?
- 2) Ted recommends establishing the value sets as "International" rather than "US Realm" I think that would make sense given the nature of the value sets we have human anatomy doesn't change in different countries.
- 3) Obtain guidance from the ADA for where SNODENT copyright information needs to be in the guide, and relative to the value sets:
 - a. Do we need to include copyright information in the Code System description (I believe this is what will appear in Rosetree for v3 terminologies, and is separate from the HL7 OID registry)?
 - b. Do we need to include copyright information in the Value Set descriptions (these will appear at the back of the IG see page 118 in the attached)
- 4) Obtain guidance from the ADA on enumeration of the Value Sets in the IG can we enumerate both the Codes and the Descriptions in the IG?

Is there some formal way you can have the ADA's position on #3, and #4 documented? I'm not sure how these types of agreements between HL7 and the ADA might be established, so let me know how we need to proceed.
